- References: APA style
- Paper Length: Maximum 8000 words (excluding references)
- Originality Requirement: Papers must be original and not previously published or submitted elsewhere
- Submission Format: Microsoft Word (.doc or .docx) only
- Review Process: Each submission will be peer-reviewed by the program committee
- Decisions (acceptance or rejection) will be based on the review outcomes
